Bishop's Report

Attended the Rostered Ministers Gathering in Atlanta, part of a 3-year cycle of gatherings: Churchwide Assembly, Youth Gathering, Rostered Ministers Gathering

Will be attending the Conference of Bishops in Chicago

Still working with churchwide to press them to move forward with a call process for a DEM

Announced that the property on which PLTS was located has been sold to Zaytuna College

Read a letter from Pr. Patricia Vargas, who has accepted a call in southern Ohio

Announced that he'll be on sabbatical during the month of November; will be located along the southern border with Mexico working on immigration and social issues, and will continue to build on his knowledge of Spanish

Pastor Katy Grindberg, assistant to the bishop

- introduced Olivia, whose working half-time at synod offices and half-time at the Belfry at UC Davis
- working a lot on mobility; will be going to Chicago for a training session on "Transforming White Privilege"
- Oct. 9 prayer service at St. John's, Sacramento, together with local Roman Catholic community, commemorating the Reformation

- working with ongoing call processes;

Vice-President's Report

- If you have the power, use it!
- Announced that she's allowing her name to go forward to stand for a 2nd term as Vice President
- Will be meeting with other Vice Presidents and Bishops at the Conference of Bishops gathering in Chicago
- Going to Charlottesville, VA in November to connect with people on a local level

Discipling Team introduction and envisioning

<u>Leadership:</u> members are committed to thinking about ways to support the rostered ministers within the synod, including the Professional Leaders Conference and a workshop on Mutual Ministry Committees; functions well with a combination of people who have been on for a long

time, and others who are quite new and who aren't afraid to ask "why do we do this?" or "why do we do things this way? Couldn't we do it another way?"

<u>Worship for Baptismal Living:</u> providing resources to congregations for worship, e.g., music workshops; training in the catechumenate

<u>Witness:</u> works closely with the DEM to support new starts and restarts, to revitalize congregations

<u>Stewardship:</u> functions well, meets at least twice or thrice per year; can serve as a resource not only for congregations, but also for other discipling teams

Original hope for the teams was to combine energy and effectiveness in supporting the mission and ministry of the synod.

How do we get more people engaged? How do we encourage more participation? Is there a way to get conferences more directly involved?

Goals:

- Maintain the currently active discipling teams
 - Gather the team chairs and the conference deans for an initial brainstorming session
 - Reestablish the periodic meeting between team chairs and executive staff
 - Possibly organize a retreat with team chairs, conference deans, synod executive staff, synod council, and an outside facilitator to discern goals and strategies and actions
 - Request information from all Discipling Teams about actions and upcoming activities
- Continue to support the rebuilding of the Racial & Ethnic Mission Strategies Discipling Team
 - Provide \$10,000 to the three working groups within the REMS Task Force to assist in moving toward rebuilding the REMS DT and developing a synodical anti-racism policy
 - Possibly to engage a facilitator to assist with this work
- To support the justice and advocacy work in our synod and to encourage communication between the different groups working in this field
 - Gather and disseminate information about justice and advocacy groups in the synod
 - Request information from all Discipling Teams about actions and upcoming activities
- Each conference to have one representative or liaison on each discipling team
 - Consider changes to Continuing Resolutions regarding populating Discipling Teams
 - Synod Council members support and attend Discipling Team and synodical activities

Merger of St. John, Sunnyvale with St. Luke, Sunnyvale:

SC17.09.38 MSC (Michaelsen/Lownes) moved Synod Council assent of the proposed merger of St. John Lutheran Church, Sunnyvale with St. Luke Lutheran Church, Sunnyvale.

SC17.09.39 MSC (Michaelsen/Lownes) moved to extend a special synodical call to The Reverend Sarah Erickson as Co-Executive Director of Mt. Cross Ministries.

Synodically Authorized Worshipping Community: "Farming Hope"

SC17.09.40 MSC (Whitney/Michaelsen) moved to authorize "Farming Hope" as a synodically authorized worshipping community of the Sierra Pacific Synod and designates Jamie Stark as its servant leader.

SC17.09.41 MSC (Holmerud/Lownes) moved to take \$10,000 from "Money Market 14" account 1-1031-000 unrestricted funds to support the working groups who are working to rebuild the REMS DT and related synod-wide activities.

Diana introduced to Council sample reports which can be produced from ACS.

Presentation on Pacific Lutheran Theological Seminary, Pastor Ray Pickett, Rector of PLTS

- 83% of PLTS budget comes from congregations and synods
- Moved to new offices in downtown Berkeley
- Developing new directions in theological education, including
 - o a new curriculum
 - o a new MA in Spiritual Formation and Community Organizing

Property Committee report

- Have executed an extension of the Burlingame office lease for 2 years.
- Announced that the Executive Committee decided to move forward with the sale of the Hilmar property

Stewardship Discipling Team overview

- Serves all of the discipling teams, as well as all congregations in the synod
- Familiarized Council members with the "mission narrative budget" model

- The art of "thank you" is so important
- Encouraged Council members to reach out to and visit congregations within their conference
